AND

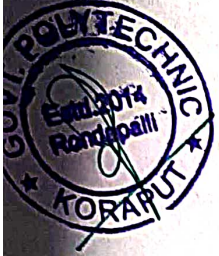
General Manager, SHIVA SAKTI OIL'S Pvt Ltd, a company companies act 2008 having registered according to rule in India the **Second Party**,

Whereas SHIVA SAKTI OIL'S Pvt Ltd. is engaged in the business Production and selling of Drown Oil Rice Bran (DORB) in the district of Koraput and other States.

Whereas GOVT.POLYTECHNIC, KORAPUT has a vision to get the students pursuing diploma in civil, Electrical and Mechanical Engineering to be placed in reputed companies. And also facilitate companies in form of providing database of interested students against openings of that company and making arrangement for campus drives to be organized centrally and training.


Now therefore, both parties hereto after intense discussion have desired to work together in common areas as per following terms and conditions:

- The MOU shall be effective from the date of its signature.
- The period of MOU shall be for three years to be extended by mutual consent for a further period of three years or more. This MoU can be terminated on mutual consent of both the parties hereto in writing.
- GOVT.POLYTECHNIC KORAPUT proposes **campus drive** to be conducted by SHIVA SAKTI OIL'S Pvt Ltd for the benefit of the students pursuing Diploma Education of this Institution by providing necessary logistic support and technical knowledge.
- GOVT.POLYTECHNIC KORAPUT plans to train the students so that they can get placement in any campus drive.
- Apart from the campus drive Govt.Polytechnic Koraput wants SHIVA SAKTI OIL'S Pvt Ltd to provide internship/apprenticeship program for the pre-final year students to enlighten and acquaint with the advanced technology.
- SHIVA SAKTI OIL'S PVT LTD shall register in Govt.Polytechnic website i.e. [www.govtpolytechnickoraput.org.in](http://www.govtpolytechnickoraput.org.in) with a unique user ID and password, provided by Govt.Polytechnic Koraput and shall conduct at least one campus drive in six months.
- SHIVA SAKTI OIL'S PVT LTD should provide their requirement with other detail criteria for the campus drive in the official portal and mail.
- SHIVA SAKTI OIL'S PVT LTD shall depute the companies 'HR along with their team for presentation regarding SHIVA SAKTI OIL'S PVT LTD profile, opening, salary structure and other facilities etc.on the day of campus drive.
- SHIVA SAKTI OIL'S PVT LTD shall make its own necessary arrangement for boarding, lodging and transportation of the HR and their team attending the campus drive.
- SHIVA SAKTI OIL'S PVT LTD shall inform the joining status of the selected candidates and also update information against all the hired candidates in the official portal of central placement cell after completion of minimum six months service/training period.



- A Nodal officer may be nominated by SHIVA SAKTI OIL'S PVT LTD to act as linkage between SHIVA SAKTI OIL'S PVT LTD and Govt.Polytechnic, Koraput.
- The database of the students participating in the campus drive shall not be provided to others by any party hereto without the consent of the other party to this MOU.
- Legal entitlement (Background check, Police vverification etc.) of skill professional hired through Govt.Polytechnic, Koraput should be borne by SHIVA SAKTI OIL'S PVT LTD.
- After joining of the candidates, Govt.Polytechnic,Koraput will not be held responsible for any misconduct shown by them and any misconduct can be dealt with as per law.
- On termination/expiry of the MOU, each of the parties hereto shall promptly return the other party's confidential information marked as confidential and copies in physical form in its possession, to the same to be informed in writing to the other party.
- All notices to be given under this MOU by any party to the other shall be in writing in English language and sent by registered mail / postage prepaid addressed to the other part at the addresses set forth above and also by email to the addresses mentioned above.
- That the parties hereto shall subject to the rules & regulation that are now in force & that may be framed by the first party from time to time, further if any deviation of MOU by the second party shall be liable under criminal law.
- This MOU shall not be amended, assigned or transferred by either party without the written consent of the other party.
